



Outvoted

A proposed change at her Step study meeting became a valuable lesson in group conscience

I got sober in Sacramento and regularly attended a women's Step study every Monday night. I found my first sponsor there and worked the Steps with her every week after the meeting. I then sponsored other women from that meeting in the same manner.

With two years of sobriety, I moved to the nearby town of Davis, but continued to go to my regular Sacramento AA meetings. After several years of only attending meetings where I got sober, I decided it would be good to make AA connections in Davis where I lived. I went to a meeting I had never been to and as the meeting ended, a newcomer rushed from the room in tears. I followed her to her car, and we stood in the street talking for a long time. I offered to be her sponsor and help her work the Steps.

Integral to my early sobriety had been that Monday night women's Step study meeting. Since there were no women's Step meetings in Davis, I decided we would start one. The newcomer found a church willing to rent space to us and the meeting was launched in the same format as the one I had attended in Sacramento: each week we read a Step from the "Twelve and Twelve" and shared about that Step.

Our Davis Wednesday Women's Step study meeting had been going strong for a while when a woman came to our meeting. Paula had been sober many years but had just moved to Davis. After attending the Wednesday meeting a few times, she asked why we didn't study the Traditions from the "Twelve and Twelve" as well. Where Paula came from the Traditions were read as well as the Steps.

In classic alcoholic thinking, I rejected that idea. Why would we waste time reading the Traditions when the program was found in the Steps? Of course, I had never studied the Traditions. But the group agreed to discuss this suggestion at our next business meeting.

On the night of the business meeting, Paula did not show up. Secretly, I was pleased. I was certain that my opinion against the change would prevail. As the business meeting progressed, we went around the room with each woman expressing her opinion about adding the study of the Traditions to the meeting format. Much to my surprise, every woman endorsed the idea. Although I had planned to argue vigorously against the change, I found myself moved by the group conscience. The vote was unanimous in favor of reading the Traditions.

Now many years later the meeting continues, and we still read the Tradition of the month. We have used a variety of AA literature to study the Traditions, including reading the monthly Traditions story in the Grapevine. I have learned much about the history of AA and how AA as a whole functions through the Traditions. I even learned how to apply them in my everyday life.

Each February I'm reminded of the beauty and richness of Tradition Two and how we arrive at a decision through our group conscience. And on a personal level, I remember the lesson of not letting contempt before investigation stunt my spiritual growth.

1. Do I criticize or do I trust and support my group officers, AA committees, and office workers? Newcomers? Old-timers?
2. Am I absolutely trustworthy, even in secret, with AA Twelfth Step jobs or other AA responsibilities?
3. Do I look for credit in my AA jobs? Praise for my AA ideas?
4. Do I have to save face in group discussion, or can I yield in good spirit to the group conscience and work cheerfully along with it?
5. Although I have been sober a few years, am I still willing to serve my turn at AA chores?
6. In group discussions, do I sound off about matters on which I have no experience and little knowledge?

Teach Me to Pray

Getting Through the Tough Times/Steps

I had never heard of the First Step when the State of California informed me that they were going to manage my life for anywhere from six months to 15 years.

That fact woke me up. I really believe that it was the first time in my life that I had to do something about myself, instead of for myself. This 38-year-old juvenile delinquent, liar, thief, con-man, knew only one way to live. Filling my own needs took up all my time. There wasn't enough energy or time to have concern for anyone else. That wake-up call helped me own the fact that my behavior put me in this California Institute.

I CAME

The man who walked through the jail door on a chain behind me that first day asked me if I'd like to go to an AA meeting. All I knew is that I wanted something better. If he had said Peanut Butter Anonymous, I would have said yes.

After hearing how drinking had affected the incoming AA volunteers, I began to look at my own drinking. Soon I found myself looking forward to next week's meeting. As members shared their stories, I became captivated like a dry spring. I couldn't get enough. I wanted in so bad that I found myself making my drinking story worse so I could belong. No one I ever knew had crept into someone's basement boiler room at 3:00 in the morning just to sleep. It was sooty and dirty, but it was warm. My whole life revolved around stealing money to get into bars and drink. I could identify with the feelings of each member.

I CAME TO

I began to be aware of small, subtle moments ... a thought to do something right, or to realize how good it is to wake up and grow up. Somehow, I was getting honest without knowing it. Soon I wanted to be the better person, instead of just trying to look good. Showing good behavior began to work despite my motives.

"Look for the motive behind the motive," my sponsor George used to say. I was amazed at how he could see through me and give me the truth.

I CAME TO BELIEVE

Still, I had trouble believing. But when I was led to Appendix II in the Big Book, where William James refers to "the educational variety," I knew I could learn. I got great suggestions from outside AA members, like: When I'm afraid to pray, say "Dear God, teach me to pray." I also did what the literature says and checked out inspirational books. One was by a well-known author, who suggested to someone who was terrified to make a presentation at work to repeat to himself 10 times, "If God be with me, who can be against me?" So I tried it. It took a while, but soon it became like a mantra I repeated in the hall, out in the yard and in my cell. I was saying it all the time. And from out of nowhere, I began to feel safe, not afraid. Behind these very large walls, I felt free.

I was learning how to believe that a Higher Power could and would restore me to sanity. Years later, I now have a nickname for it. I call it "the grace of God."

Like the Layers of an Onion

No One can be Turned Away

The only requirement for AA membership is a desire to stop drinking. (Trad. Three 12&12) After many years of sobriety and practicing the AA principles to the best of my ability, I am amazed at what I see in the meetings that I attend. It was one of the most important developments in my later years of sobriety. Removing my judgmentalism of other people in AA, that have a desire to stop drinking. I have come to understand that tradition, but it did not happen immediately. I was overwhelmed with personal problems that eventually culminated into my surrender and came to AA searching for answers. I am so grateful that they did not turn me away because I had problems.

The AA Program is so much deeper than I ever could have imagined when I first entered it. Over time, I recognized the depth of each issue that we face when we come clean with ourselves and with the world around us. It is sometimes likened to the layers of an onion. The surface skin begins to fall away quickly as we address the drinking part of our disease. Each layer is preparatory to the next. As we recognize and begin to discard the negative side of our thoughts and behaviors, we begin to understand that our thinking is where the problems lie, and our behaviors are the symptoms of that faulty thinking when our natural instincts far exceed their intended purpose.

In my early days of sobriety my mentors suggested that if I plan to attend a certain number of meetings per week, one of them should be a step study meeting and I have followed that suggestion ever since. One of the benefits of that decision is that we study each step four times a year and each time I repeat a previous step I notice an improvement in my understanding of that step. In the presence of that group, I may hear 20 to 30 different perspectives on how to address my faulty thinking and all those viewpoints are stored in my mind as I peel away one more layer of the onion. I learned the value of living by unselfish principles and that simple understanding takes most of my decision-making out of my hands. Principles are not flexible, and I do not create my own principles. I do, however, have the ability to follow well-established ethics and even then, sometimes things may go wrong but my motives are of an unselfish nature, and I do my best. I learn to be prudent when it comes to my decisions. I learn to decide if it was my Ego or my Conscience making that choice and today my Conscience renders my Ego irrelevant for the most part. I have always known right from wrong but with my fears and insecurities I usually made the wrong, selfish decision and my conscience suffered. If I already know when I am doing the wrong thing, why am I praying to God when I already know the answer and still make the wrong choice? It is true that the only requirement for membership is a desire to stop drinking but in AA I found so much more.

Within the safety of my AA group, I get to test these qualities out and establish a new perspective, unselfish in nature, as I peel away layer after layer and my load gets lighter and lighter. I no longer look at this process to be ponderous. I now see it as exciting and I want to continue to look deeper into my spiritual condition, living by the dictates of my conscience, and I hope this process never ends as I trudge that road of happy destiny.

Dear Trusted Servants:

A.A.'s Co-Founder, Bill W., in his 1953 address to the General Service Conference, stated that he did not consider himself the author of *Alcoholics Anonymous*, the Big Book (*Our Great Responsibility*, p. 92). He also alluded to the fact that in the various A.A. literature published prior to his passing, he borrowed heavily from other sources, and that other A.A. members made significant contributions.

On the other hand, addressing the historical context of some of the writings of our Founders, many members in our Fellowship have expressed strong sentiment against any changes in the first 164 pages of *Alcoholics Anonymous*, the Big Book, as well as the Preface, the Forewords, The Doctor's Opinion, Doctor Bob's Nightmare, and the Appendices. In fact, as early as 1995 and most recently in 2022, Advisory Actions designed to protect the above-referenced contents have been passed by the General Service Conference.

In response to a Committee Consideration from the 73rd General Service Conference suggesting that trustees' Literature Committee *seek input from the Fellowship (including but not limited to Area delegate feedback) regarding any possible future changes to literature written by A.A.'s Founders*, the trustees' Literature committee agreed it would be beneficial to gather shared experience from the Fellowship regarding this topic.

We would like to hear from you – the top of the triangle! While we hope that the suggested questions will help to spark thoughtful sharing and discussion, please feel free to add questions that we may not have thought of that you feel may best inform the discussion. Most of all, we are grateful for and thank you for your participation.
