I've done it all. I don't drink. I go to meetings. I call my sponsor. I did the Steps. I gladly do service. And of course, I reach out to help other alcoholics.

But after all of this, there's more? Apply the principles of AA "in all my affairs"? Every day? Forget it. That's simply too much to ask this recovering alcoholic, no matter how many years I have in the program.

Most of the time I do quite well. Remember, "it's progress, not perfection."

At a restaurant, wedding, fancy party or ball game, I'm an AA superstar. But doing the family food shopping? Now that's another story. If you see me "in action" at a grocery store, please, I beg you, don't tell my sponsor how I acted when...

- 1) The shopper in front of me in the "15 items or less" line starts to place 27 items on the conveyer belt.
- 2) The guy in front of me leaves the checkout counter to get the one item he "forgot."
- 3) Someone has an endless conversation with the cashier about her granddaughter's amazing report card.
- 4) "Starving" shoppers reach and grab food from the salad bar, using their hands.
- 5) A driver cuts me off to get the last remaining parking spot.
- 6) I get to the store and it doesn't open its front door one minute early, leaving customers to freeze outside. And...
- 7) An SUV has been parked so close to my car that I can't even open my door to get in.

I'm 76 years old with 28 years in the program. It may be too late for this grouchy old-timer to change no matter how many times I do the Steps.

But thankfully, I can always do another Step 10. I'm an expert at apologies. Though I'd rather be an expert at "doing the next right thing."

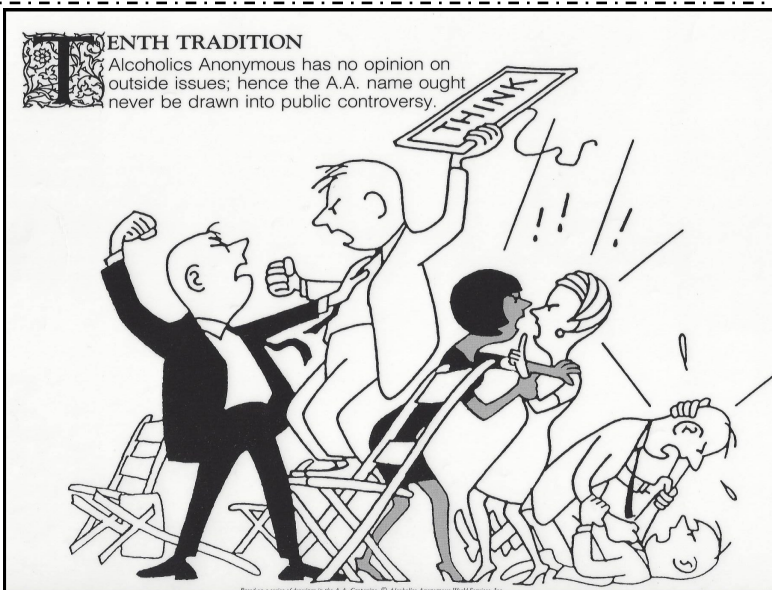
**TRADITION TEN:** (The Long Form)

**TRADITION TEN: Check List**

1. Do I ever give the impression that there really is an "AA opinion" on Antabuse? Tranquillizers/ Doctors? Psychiatrists? Churches? Hospitals? Jails? Alcohol? The federal or state government? Legalizing marijuana? Vitamins? Al-Anon? Alateen?
2. Can I honestly share my own personal experience concerning any of those without giving the impression I am stating the "AA opinion"?
3. What in AA history gave rise to our Tenth Tradition?
4. Have I has a similar experience in my own AA life?
5. What would AA be without this Tradition? Where would I be?
6. Do I breach this or any of its supporting Traditions in subtle, perhaps unconscious, ways??
7. How can I manifest the spirit of this Tradition in my personal life outside AA? Inside AA?

## Defending AA

After a heated debate on the internet, a member learns a lot about putting on her gloves for AA

The importance of both Traditions Ten and Eleven was brought home to me recently in my excessive zeal to protect AA's good name. When they were approved by AA's first General Service Conference in 1950, press, radio and films, what today are known as the mainstream media, were all AA had to consider. But with the evolution of the internet, there has been an explosion in our channels of communication. This presents tremendous opportunities for AA to carry our message of recovery, but these new ways of communication also carry dangers. Today there are many Fellowship websites, as well as a bewildering range of links to other groups, some of which are virulently hostile to AA.

I once made the mistake of challenging one of these groups, in which a writer accused AA of being responsible for the disease concept of alcoholism. He asserted that no one was powerless over alcohol and that addiction was a choice. I pointed out that AA literature, especially the Big Book, is careful not to describe alcoholism as a disease, but uses terms like illness or malady. This resulted in a lengthy correspondence which became more and more heated, though not more illuminating.

I found myself lying awake at night planning my next email salvo to demolish my ignorant adversary. To gather ammunition I wrote to AA's General Service Office in New York, but with great good humor they gently refused to take my side. This was part of the letter I received from the Public Information assignment staff member:

*"There was a recent television program in the United States which was highly critical of the AA program and generated anger and antagonism. The numerous requests for this AA office to react or defend Alcoholics Anonymous were met with a gentle reminder about our Tenth Tradition. We also pointed out Bill W.'s guidance in Concept Twelve, 'Let us suppose that AA does fall under sharp public attack or heavy ridicule; and let us take a particular case where such pronouncements happen to have little or no justification in fact. Almost without exception it can be confidently estimated that our best defense in these situations would be no defense whatever—namely complete silence at the public level' (AA Service Manual/Twelve Concepts for World Service).*

*"This public relations policy is one which we at this office heartily endorse. We also believe that it ought to serve as a thoughtful guide to all members of the Fellowship. Though a response to outside criticism may of course be done on a personal level, the mere fact of offering an opinion as an AA member may lead to a public discussion where the line between the personal and the Fellowship's opinion may become blurry in the public's mind.*

*"Our role as a society of recovered alcoholics helping others does not endow us with any medical or scientific stature. Therefore, the issue of a medical determination of a disease is something on which AA could have no position. Our Traditions are clear in reminding us to not be diverted from our primary purpose as a Fellowship and as members of that Fellowship we should respect the limitations we have. Doctor Silkworth's view of alcoholism is still contained in the basic text Alcoholics Anonymous, though as a separate and distinct Foreword. It may lack a certain medical credence these days, though the ideas still resonate with many AAs and newcomers."*

I learned my lesson. I stopped springing to AA's defense when I saw our Fellowship traduced or misrepresented in the media. As the long form of Tradition Eleven says, "There is never need to praise ourselves. We feel it better that our friends recommend us." Apart from anything else, these sometimes egotistical but often well-meaning interventions were enticing distractions that enfeebled my primary purpose, which is to stay sober, and as far as I can, help other alcoholics to get sobriety.

Fellow members,

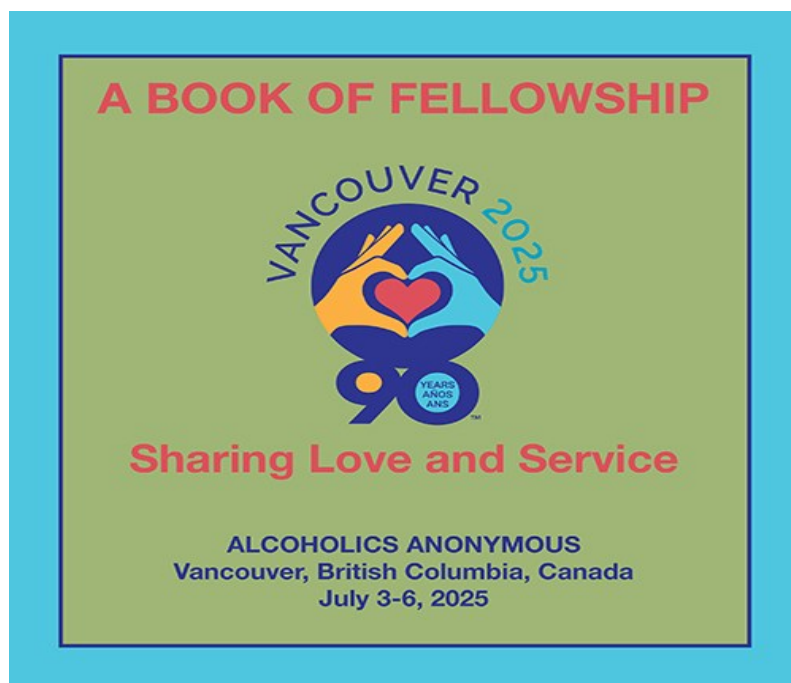
